Immediate Opportunity to Reduce Scope 2 Emissions and Be RE100

Putrajaya, 10 August 2023 – We, the Energy Commission are pleased to announce that the Green Electricity Tariff (GET) programme will re-open tomorrow (11 August 2023) for new subscriptions from 11:00 am – 5:00 pm, with an available green energy quota of **1,899 GWh** for the 5-month contract period from 1 August 2023 to 31 December 2023.

The GET programme enables RE100-focused and ESG-conscious companies/industries to immediately obtain **certified** Green Energy up to 100% of their monthly electricity consumption, and thus these companies/industries can immediately achieve their RE100 goal with the internationally acclaimed and recognised Malaysia Renewable Energy Certificate (mREC).

The mRECs certify that every kWh of Green Energy purchased by the GET subscriber is uniquely identified to the particular Renewable Energy generation source, which in turn is connected to the National Grid infrastructure and thus dispatchable to the GET subscriber.

The GET programme also provides the successful GET subscriber with full exemption from the ICPT charges on their green energy utilised, in their electricity bill.

The Energy Commission would like to remind applicants that the allocation of the aforementioned available Green Energy quota under the GET programme is for eligible customers, on a “first-come, first-serve” basis and therefore, interested applicants are reminded to subscribe early within the application window of 11:00 am – 5:00 pm tomorrow, 11 August 2023, by logging-in to myTNB Portal at www.myTNB.com.my.
