

**ENERGY COMMISSION STATEMENT
ON THE REVISION OF NATURAL GAS TARIFF
FOR GAS MALAYSIA BERHAD CUSTOMERS**

1. In line with our national subsidy rationalization plan to ensure sustainability of natural gas supply to meet increasing demand from the non-power sector, the government has decided that effective 1 January 2016, the tariff for natural gas supplied by Gas Malaysia Berhad (GMB) be revised as follows:

The revision of GMB tariff with an average increase of 17.11 percent as above has to be undertaken following the increase in the volume of imported liquefied natural gas and the decrease in the value of the Ringgit, despite declining world market price of liquefied natural gas and efficiency improvement in GMB operations. However, this revision of GMB natural gas tariff does not involve domestic consumers.

**KENYATAAN SURUHANJAYA TENAGA
MENGENAI SEMAKAN SEMULA TARIF GAS ASLI
BAGI PELANGGAN GAS MALAYSIA BERHAD**

1. Selaras dengan pelan rasionalisasi subsidi negara bagi memastikan bekalan gas asli adalah sentiasa terjamin untuk memenuhi permintaan sektor bukan tenaga yang kian meningkat, kerajaan telah memutuskan bahawa berkuatkuasa 1 Januari 2016, tarif bagi gas asli yang dibekalkan oleh Gas Malaysia Berhad (GMB) disemak semula seperti berikut:

2. Semakan semula tarif GMB dengan kenaikan purata sebanyak 17.11 peratus seperti di atas perlu dilaksanakan ekoran peningkatan isipadu gas asli cecair yang diimport dan penurunan nilai Ringgit, walaupun harga pasaran dunia gas asli cecair telah menurun dan kecekapan operasi GMB telah meningkat. Bagaimanapun, semakan semula tarif gas asli GMB ini tidak melibatkan pengguna domestik.
